Policy #6 PROGRAM COMMITTEE RESPONSIBILITIES

Programming Task Break Down

A.

The Program Director, AM News and Public Affair Director, and/or the PM News and Public Affairs Director (called Program Staff for the rest of this document) can take these actions:

- 1. Suspend programmers for technical reasons or for not fulfilling on air responsibilities laid out in the Programmers Contract.
- 2. Develop new programming.
- 3. Fill attrition slots in cases of no format change no consultation with the Program Committee is required.

- 4. Fill attrition slots if there is a format change Program Staff should seek advice and recommendations of the Program Committee.
- 5. Change Existing Programming after seeking advice and recommendations of the Program Committee.
- 6. Develop overall standards for broadcast and podcast.
- 7. Shape yearly goals for programming.
- 8. Revise programmer rights and responsibilities document as needed
- 9. Any other items listed in the current job description.

В.

The Program Staff works through the Program Committee to:

- 1. Provide active leadership of the Committee
- 2. Shape yearly goals for Program Committee
- 3. Ascertain community needs in a pro-active and mission-driven way on a regular basis
- 4. Evaluate broadcast and podcast programming quality on a regular basis
- 5. The Program Staff is required to report all Programming changes to the Program Committee.

C.

Program Committee is responsible for:

- 1. Assisting Program Staff in shaping all policy items listed in the "Program Staff works through the Program Committee" section above.
- 2. Working with the Program Staff to solicit input from community.
- 3. Working with the Program Staff to meet yearly Program Committee goals.
- 4. Serving as the Community Advisory Board to Ascertain Community needs.
- 5. Serving as a work group to assist Program Staff in all areas as needed

D.

Committee makeup:

- 1. Committee is self appointed (any KBOO Foundation member who attends three meetings in a row and who agrees to fulfill responsibilities can become a voting member).
- 2. The Board has the option to appoint a maximum of five (5) individual from underrepresented groups at any time. The appointees will have immediate voting rights.
- 3. There will be at least one and no more than two (2) members of the Board on the Committee. One (1) additional staff member besides the Program Staff can be a voting member of the committee.
- 4. The Committee is open to new membership any time.
- 5. Any member who misses three (3) meetings in a row or consistently does not fulfill Program Committee responsibilities shall be removed as a voting member.

6. Board appointed members will be re-appointed by the Board.

Policy #22 Programming Changes

PROGRAMMING CHANGES

All proposed programming changes shall be presented to the Programming Advisory Committee for discussion, as per the Programming Task Breakdown Policy A5.

The Program Advisory Committee will advise Program Staff on Major Programming Changes.

Major Programming Changes are defined as

- 1) Change or removal of a single program for not following KBOO mission or approved program description
- 2) changes that affect more than one program

Procedure for Major Programming Changes

- 1) PAC will ask Staff to investigate a program after evaluation has shown they are not following the mission or have developed the program in a way that is inconsistent with the approved program proposal.
- 2) Staff will meet with the programmer to find out why they are not doing the program as it was approved.
- 3) Staff will report back at the next Program Advisory Committee and invite the affected programmer(s) to the meeting for problem solving, and next steps. Opportunities for public input shall be given at the meeting.
- 4) The Programming Advisory Committee shall make a recommendation to the Program Staff concerning the proposed change at the committee's next meeting.

After considering the recommendation of the Programming Advisory Committee, the Program Staff shall decide whether and in what manner to implement the proposed change. The Board may overturn the decision of the Program Staff if, and only if, it finds that decision to be inconsistent with the KBOO

Programming Charter and Mission, and the criteria for making programming decisions.

Program Change Criteria:

KBOO accepts the fact that there are numerous communities, most of which have no access to radio. In making programming decisions, the Program Staff and Programming Advisory Committee shall use the following criteria.

Our goal is programming that:

- Furthers the goals and values set forth in the KBOO programming charter and mission statement
- Does not discriminate on the basis of race, color, creed, national origin, gender, sexual preference, age, religion, marital status, or physical or mental disability
- Encourages positive relationships and increased understanding among different cultures
- Provides exposure to innovative and unrecognized cultural, music, and spoken word programming
- Strives for technical as well as overall quality
- Does not proselytize a religion
