George (From 7pt Leadership Training and Culture Leadership RACC Training) Presents

It is not uncommon in the non-profit world to struggle with getting quorum. Moving money from checking to reserve is a good thing. (Seldom do orgs move money into the reserves) so KBOO is doing great in that aspect.

George works on planning for organizations to strengthen organizational side to better support folks to do the programming side.

Works with numerous Arts and Culture organizations.

Focus on

- 1) Raising money and how much.
- 2) Recruiting folks for the board
- 3) What is the purpose and function a successful board-there is no singular model, each org has its own operating reality. (KBOO Foundation Board is not like the Status Quo Model)

How do we more successfully recruit board members?

Start with your known universe (aka Membership)

Choose a segment of that universe and meet with folks, thank them for what they already do, then ask if they are interested in deepening their relationship with KBOO. Have a 'menu' of what the board needs and pursue a pathway where their skills intersect with board needs and specific expectations of board members before appointed to board.

Communally develop work plans for each individual board member. Personalize work plans without 'shoulds' or 'nots'.

Sign work plans which can/may change organically without blame.

Questions for Board

How do we engage with human help?

-Old thinking people can only help if they join the board-New way folks can participate with out being on the board....Using "Resource Council" which functions as a way to recognize volunteers who do work that typically fall on board.

What are all the job needs and tasks that we need to do as an organization?

- -We need to list and find allies.
- -We need to find priorities that are most critical.

Expectations for Board

- 1) Any member of board must have a deep commitment to the org, it's mission and it's activities.
- 2) Every board member must participate in raising community recognition, visibility and awareness of what the organization does (this is an ongoing process) Ask who needs to know about KBOO?
 - -People we already have relationship with-how we can we deepen and expand the relationship
 - -People who we don't have connection with
 - -People who have an idea that is incorrect about KBOO
- 3) Development and fundraising by all members of the board
 - -Creating an umbrella of understanding
 - -95% is development of relationships %5 the ask
- 4) Board members personal financial donation each year. 100% of membership is donated each year by each board member.
